Dear Sisters in the League,

Congratulations on all the work you have done in 2010. Donations are up from last year.

From the 55 councils that reported, 29 councils made an annual budget, 52 made financial monthly reports,
42 budgeted for convention and 49 spent money on League Development.

Donations reported were as follows:

National Voluntary Fund - \$ 14,893.28	Communications - \$ 8,322.52
Spiritual Development - \$ 24,369.25	Community Life - \$ 45,804.46
Education and Health - \$ 24,461.14	Parish Life - \$ 88,043.54
Christian Family Life - \$ 27,544.36	

The fundraising amount donated by councils was \$233,438.55. This money was raised through Thrift Shops, Share Shops, Religious Articles Sales, Concession Booth at Pilgrimage, Mission Calendar Sales, Raffles, Bazaars, Fall Fairs, Fall Bistros, Fall Fashion Shows, Craft Sales, Catering, Funeral Lunches, Mom's Pantry, Farmer's Markets, Pancake Breakfasts, Brunches, Luncheons, Tea & Pie Socials, Dinners, Silent Auctions, Hot Dog Sales, Cabbage Rolls Sales, Baked Potatoe Sales, Pie sales, Meat Sales, Meat Pie Sales, Quiche Sales, Perogy & Apple Pie Sales, Calendar Sales, Cook Book Sales, Garage Sales, Rummage Sales, Coffee & Cinnamon Buns Sale at Garage Sale, Tea Sales, Fair Trade Coffee Sales, Christmas Cards Sales, Christmas Certificates, Christmas Wreaths, Christmas Cakes Sales, Christmas Pudding Sales, Cookie Walks, Providing childcare for Foster Care Agency, Anniversary Booklets, Grey Cup Pool Tickets, 50/50's, Bottle Refunds, Donations, Bingos and Co-op Till Tape Program.
